<i>Information We Collect</i>	We may collect the following types of personal data: • Name • Email address • Phone number • Company name • Passport number or ID (for bookings and travel arrangements) • Date of birth (if required for travel) • Payment details (processed securely through third-party providers) • Travel preferences (e.g., dietary requirements, accessibility needs) • IP address • Any other information you choose to provide through our contact forms, email, or other communication We may also collect non-personal data such as browser type, device information, and website usage statistics through cookies and analytics tools.
<i>How We Use Your Information</i>	We use your data to: • Respond to your inquiries or requests • Process bookings and travel arrangements • Provide our services • Communicate with you about your trips or inquiries • Send travel confirmations, invoices, and updates • Send updates or marketing communications (only if you've consented) • Improve the performance and usability of our website • Comply with legal obligations
<i>Legal Basis for Processing</i>	We process your data based on: • Contractual necessity – to fulfill travel bookings or provide services • Legal obligations – such as visa documentation or travel regulations • Your consent – for marketing communications • Legitimate interest – to improve our services and user experience
<i>Sharing Your Information</i>	We do not sell, trade, or rent your personal data to third parties. We may share your data with:

	• Service providers who assist us in website operation (e.g., hosting, analytics) • Airlines, hotels, and local travel partners (only relevant data) • Payment processors • IT and website service providers • Authorities if required by law • Government authorities or customs/immigration offices (if legally required)
<i>International Data Transfers</i>	As a travel company, your data may be shared with partners outside the UK/EU (e.g., hotels or tour operators abroad). In such cases, we ensure that appropriate safeguards are in place to protect your data.
<i>Data Security</i>	We take appropriate technical and organisational measures to protect your personal data against unauthorised access, loss, or misuse. Payment details are handled by secure, PCI-compliant platforms.
